Metod of application: brush, microfibre cloth,

Preparing the surface

- Remove wax and other polishes product
- Wash surface using C2 Sea-Line Concentrate Cleaner
- Surface must be dry and should not have contact with water, fog, dew before application COLOR RENOVATION at least 12 hours.
- Protect white surface against COLOR RENOVATION
- Apply on the surface quantity which you can used in time 20 minutes.
- Apply COLOR RENOVATION Sea-Line[®] on the surface using brush or microfibre cloth
- Leave COLOR RENOVATION Sea-Line[®] on the surface for 20 minutes.
- Remove excess COLOR RENOVATION Sea-Line[®] from the surface.
- Allow to dry.

Further work:

- After 24 hours to increase shine we can polish surface using microfibre cloth.
- To remove defects we can polish surface using polishing compound S1 Sea-Line or finishing compound S2 Sea-Line.
- Recommended surface protection
 - S5 Sea-Line Quick Wax
 - S4 Sea-Line Protect Wax
