Technical information

Product components : Teak cleaner C4 – one pack product

Volume: Single pack 250 ml

Product description : Sea-Line® C4 TEAK CLEANER is a very powerful water-soluble, biodegradable concentrate for quick and efficient cleaning of teak wood. C4 restores color and leaves no residue (as opposed to acidic products). It contains no acids and is safe for adhesives and sealants.



Recommended use: Sea-Line® C3 is indispensable at a rapid restoration of the color of exotic wood.

NOTE: Do not use on glass and mirrors.

Physiochemical Characteristics:

Type: liquid
Color: transparent
Smell: specific
Solubility in water: 100%

Preparing the surface: Wash the surface other contaminations (for example sand) with fresh water.

Method of application: Soft brush.

Application :

- Dirty wood surfaces soak fresh water.
- Thin Sea-Line® C4 with water (can be diluted with warm or cold water):
 - 1:20 for normal dirt (add 1 part of C4 on 20 parts of water).
 - 1:10 for heavy dirt (add 1 part C2 on 10 parts of water).
- Wash surface the soft brush (alongside the wood grain).
 - On very dirty surfaces leave C4 for few minutes then clean with soft brush (alongside the wood grain).
- After treatment, always rinse with plenty of water.

Further Work : After drying and evaporation of water from wood, protect the washed surface dedicated to the exotic wood oils.

General Cautions :

- Please follow safety instructions from the technical data sheet and follow workplace safety laws.
- Avoid contact with eyes.
- If swallow, immediately seek medical advice and show the container label.

Storage :



Product contents should be kept in tightly sealed containers, at a temperature between 5-35°C, far away from sources of fire, heat, and UV rays. Close the containers tightly immediately after every use. Keep away from children.

Caution: After every use, containers should be closed immediately!

Expiration date : 36 months from the date of production.
